

# **ELECTROCARDIOGRAPH TECHNOLOGY (EKG)**



#### **Description of Program**

The Electrocardiograph (EKG) Technology program prepares students for employment in roles such as electrocardiograph aides, EKG technicians, and cardiovascular technologists or technicians. It also serves as supplemental training for individuals currently or previously employed in the field. EKG technicians—also known as cardiographic or electrocardiogram technicians—perform diagnostic tests that assist physicians in identifying and treating cardiovascular conditions. The program covers a wide range of topics including communication and interpersonal skills, an overview of human anatomy and physiology with a focus on the cardiac and vascular systems, medical terminology and transcription, patient care techniques, medical instrumentation, cardiovascular pharmacology, interpretation of monitoring and test results, medical ethics, cardiac wellness and rehabilitation, safe work practices, CPR, Basic Life Support (BLS), and employability skills. The integration of theoretical instruction with practical experience prepares students to take the Certified EKG Technician assessment.

# **Florida Residency for Tuition Purposes**

A "Florida resident for tuition purposes" is defined as someone who has, or a dependent person whose parent, legal guardian, or spouse has, established and maintained legal residence in Florida for at least twelve consecutive months prior to the first day of the academic term. Individuals who do not meet this requirement are classified as non-Florida residents and are subject to a higher tuition rate. To be considered for in-state tuition, applicants must complete the *Florida Residency Affidavit for Tuition Purposes* and submit *two supporting documents* that verify Florida residency. For detailed information on acceptable documentation and to access the form, please refer to the admissions process or contact a program counselor or advisor for assistance.

# **Basic Skills**

Students enrolled in programs of 450 hours or more are required to take and pass a basic skills test in order to receive a Career Technical Education certificate upon program completion. However, students enrolled in

programs that are less than 450 hours or Applied Technology Diploma (ATD) programs are not required to take the basic skills test. Additionally, some students may qualify for exemptions based on specific criteria.
