### Description of Program

The Patient Care Technician program is designed to prepare students for employment in a variety of roles, including advanced cross-trained nursing assistants, patient care technicians, health technologists and technicians, healthcare technicians, patient care assistants, nursing aides and orderlies, home health aides, and allied health assistants. Working under the supervision of doctors, nurses, and other medical professionals, patient care technicians provide essential care to ill or injured patients in both acute and long-term care settings such as hospitals, nursing homes, and home health environments. The program content includes training in taking vital signs, collecting specimens, performing 12-lead EKGs, basic phlebotomy techniques, safety and security procedures, and personal patient care practices. Through a combination of classroom instruction and hands-on clinical experience, the curriculum prepares students to sit for the Certified Nursing Assistant (CNA) and Patient Care Technician (PCT) examinations administered by the Florida Board of Nursing.

## Florida Residency for Tuition Purposes

A "Florida resident for tuition purposes" is defined as someone who has, or a dependent person whose parent, legal guardian, or spouse has, established and maintained legal residence in Florida for at least twelve consecutive months prior to the first day of the academic term. Individuals who do not meet this requirement are classified as non-Florida residents and are subject to a higher tuition rate. To be considered for in-state tuition, applicants must complete the **Florida Residency Affidavit for Tuition Purposes** and submit **two supporting documents** that verify Florida residency. For detailed information on acceptable documentation and to access the form, please refer to the admissions process or contact a program counselor or advisor for assistance.

## Basic Skills

Students enrolled in programs of 450 hours or more are required to take and pass a basic skills test in order to receive a Career Technical Education certificate upon program completion. However, students enrolled in programs that are less than 450 hours or Applied Technology Diploma (ATD) programs are not required to take the basic skills test. Additionally, some students may qualify for exemptions based on specific criteria.
