Description of Program

Real estate sales associate licensees must complete a 45-hour post-license education course prior to their first license renewal deadline to fulfill the license renewal requirement. This required course must be completed within 24 months of receiving your sales associate license. Of all the renewal courses, this course is the most important. If you do not complete the post-license course on time, your license will become null and void. Don't let your license expire!

Prerequisite:

1. Must be licensed as a real estate sales associate in Florida to enroll in this course.
2. Must provide FL real estate license number as a condition of enrollment

3. Report to the Registration Office with a valid state or government issued picture ID
4. Complete the registration form
5. Pay (cash, Visa, or MasterCard)
